

INSTRUCTIONS

FOR CURRENT LEASEHOLDERS:

Per the Harbor Rules, a Slip Assignment, wet or dry, must be renewed every year. Completed Applications along with the required paperwork are due in OCTOBER for renewals for the following calendar year. Although reminders MAY be sent out by email, it is the responsibility of the leaseholder to obtain and submit new paperwork each year as is required. Those who fail to do so are subject to fines and/or loss of slip assignment and removal of their vessel at the owners expense.

FOR NEW APPLICANTS:

A new application for Slip Assignment, wet or dry, may be submitted at any time of the year and must include the paperwork requested on the application. No application will be accepted without proper proof of registration and insurance.

Note that the boat for which an applicant is applying for a slip MUST be owned by the applicant, a member of Fairhope Yacht Club. In the case of multiple owners, ALL owners must be members and all members information must be given on the application and be listed on the registration and insurance; however, *the slip will be assigned to only one member*. See the Harbor Rules for additional information on this special situation.

FOR THOSE ALREADY ON THE WAITLIST:

Per the Harbor Rules, you must submit a new application each year, due in October, to remain on the Wait List.

Note that the application must be accompanied by the required paperwork and include any necessary information on joint owners.
